- 3. That the school is being run as community service and not as a business and that commercialization does not take place in the school in any manner whatsoever.
- 4. That no part of income from the institution is being and will be diverted to any individual in the Trust/School Management Committee or to any other person/entity. That the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of the land.
- 8. That the school will ensure compliance of all statutory requirements like EPF, ESI and Labour law etc. with respect to the school and staff of the school.
